


Take Root in China with Leading Technologies

Compared with 7 years ago, STÜKEN makes much greater achievements now. It has been the leader in the industry by virtue of advanced management, leading technology, sound service system and growing technical team. "STÜKEN has experienced a great change in past 7 or 8 years. Firstly it


successfully implements its globalization strategy. STÜKEN Shanghai also makes a great transformation, from early extensive electronic products into more precision automobile parts, and has been providing services for many tier-one suppliers in the automobile parts industry. Its business develops quite fast in the Chinese market. STÜKEN has set up the manufacturing sites in China, USA, Germany and Czech, and has extended

their sites in Germany, USA and Czech recently. All of its global subsidiary companies cooperate closely and provides the same client base with globalized service. In 2017, STÜKEN has a global sales volume of over Euro 0.2 billion, and its sales volume in China contributes 14%," says Schmidt.

Definitely, manufacturing as a foundation for a national economy and a social motivating force, can support and sustain the advance and innovation of all industries. As for initiatives Germany Industry 4.0 and Made in China 2025, STÜKEN acts as both an active advocator and a major promotor. China learned German technologies and promoted them to a higher level. Our manufacturing sites in Germany have basically entered a Germany Industry 4.0 level and the ones in China are heading to such level," expresses Schmidt.

STÜKEN applies high-precision measuring tools,






measuring microscope and advanced analysis techniques in its manufacturing processes. "We highly values precision, stability and quality, which are our competitive advantages. With the development of the industry and the Chinese market, more and more clients adopt automated production lines and attach great importance to stable quality of raw materials and components to guarantee production efficiency, superior quality and high

why an increasing number of clients choose STÜKEN. STÜKEN develops business in a wide range, but regards the auto industry as its main market, because the auto industry is its most preferred business field. STÜKEN's high quality is firstly embodied in products. We provide clients with stable products as well as excellent post-processing

procedure. Now automobile users have high cleanness requirements on products, for example, injection systems in engine, accordingly, STÜKEN use secondary processing with high quality. Besides products, STÜKEN does more and better in environmental protection," says Schmidt.

Qualified personnel are a very important factor in maintaining STÜKEN's success. STÜKEN emphasizes training and development of qualified personnel, so that it provides a stage on which all staffs can maximize their individual potentials as well as an atmosphere in which they work and live in a fair and harmonious way. predicated on the basis of the current data that STÜKEN would have an annual growth rate of at least 25% in the Chinese market in next three or four years. STÜKEN will build new plant buildings, expand production equipment and double the production capacity, so we are confident of our development in China," expresses Schmidt,

talking of the future planning and layout.
