当今的中国, 已经在 世界经济舞台占有不可或 缺的重要地位, 正在成为 全球经济增长的中心,经 过改革开放 40 年的飞速 发展,已成为世界经济的 发动机。IHI 集团以其敏锐 的市场洞察力和长远的战 略眼光于改革开放初期就 吹响了进军中国市场的集 结号,成为改革开放第一 批进入中国的知名跨国公 司,并取得了可喜的发展。 适逢中日友好条约缔结 40 周年之际,为进一步了解 IHI 的发展和取得的成就,

记者专程采访了株式会社 IHI 理事、中国总代表菅沼禎郎先生、石川 岛(上海)管理有限公司总经理藤森洋一先生。

菅沼禎郎总代表首先介绍说:"IHI集团创立于1853年,有

160多年的悠久历史。早期由造船业起家,之后相继拥有了转动设备技术、大型构造物的焊接结合技术、机械加工技术和热能源利用技术。正是因为这些技术奠定了集团发展的基础,到如今,可以说天上飞的宇宙航空器、地面上运转的产业机械、社会基础设施和海洋设施以及资源·能源·环境设施均成为我们集团的引以为自豪的领域,形成了 IHI 集团的四大事业板块。目前,IHI 集团年销售额达到 900-1000 亿人民币的规模,IHI 集团的员工活跃在世界各地,达 3 万多人,业务范围遍布全球。要强调的是,中国是 IHI 集团在全球重点投入的包括东南亚的亚太地区、美洲地区的三大战略区域之一。"



国邦交正常化大型纪念活动,1974年,IHI向前武汉钢铁厂提供了一套钢板宽度1米7的热轧设备。此后相继向宝钢以及鞍钢等著名钢铁厂提供了钢铁生产线。随着中国改革开放的进展,IHI在中国的业务领域不断扩大。1986年 IHI 在北京成立了办事机构,以此为依托,相继在全国拓展业务。设立在上海的管理公司统括管理着中国域内各公司,员工60余人,北京和大连设有分公司。中国域内的集团所属企业有14家,按产品类别划分,其中2家是汽车发动机用涡轮增压器生产企业,2家是农业机械生产企业,以及其他产业系统和通用产业机械制造企业。中国域内公司的年销售额达到50-60亿人民币,并形成逐年递增的发展态势。

IHI 是一个大型综合重工业集团,在国内外拥有丰富的经验和业绩,在国际上赢得了广泛的信誉。在社会基础产业领域包括设计、采购、施工以及售后服务等,具有大型项目的综合建设能力。公司拥有全球

"IHI Corporation, established in 1853, started from shipbuilding and extended its business to rotating equipment technology, large structure welding technology, mechanical processing technology and thermal energy utilization technology. 

In 1972, China and Japan achieved their normalization of diplomatic relation. In 1974, ingratiating the large memorial event of China-Japan normalization of diplomatic relation, IHI Corporation provided Wuhan Steel and Iron Works with a set of 1.7-meter-wide hot rolling equipment. Since then, it delivered steel production lines to famous steel plants such as Baoshan Steel Corporation and Anshan Steel Company. With the progress of China's reform and opening up, IHI Group extended its business range gradually. In 1986, IHI Corporation set up an office in Beijing, based on which, IHI spread its business across China. Its management company in Shanghai has its branch offices (in Beijing and Dalian) and over 60 staffs in China. 2) accurately communicate such objective to all staffs; 3) the staffs set up their respective objectives on the basis of the overall objective above and their responsibilities; and 4) check the performance of staffs relative to their respective objectives. Any excellent one who has outstanding contributions to the corporation will be rewarded in superior," says Suganuma.

"The 14 subsidiaries and affiliates of IHI Group in China all are arranged with independent management. Each company has its independent accounting unit. What we do is to optimize and accelerate their daily operation. To strengthen the communication and coordination between these companies, we communicate each company closely through regular CEO meetings. The service aims of IHI Group are as: 1) serve clients better; 2) serve staffs considerately; 3) contribute to local society or country; and 4) be responsible to stockholders," adds Suganuma.

The Chinese government will actively push forward the sustainable development featured in energy conservation, emission reduction, greenness, low carbon and cycling, strengthen an energy-efficient and environment-friendly production mode, and enhance the development sustainability. IHI Group has been following the sustainable development philosophy, delivering the solutions to cope with a good many challenges in environment, energy, industry and social infrastructure faced by us in in the 21st Century, and striving to be a global firm that brings human being wealth, safety and harmony. "We set up an industry engineering system department in charge of automatic warehouse and production. In energy conservation aspect, we make efforts to not only help each element develop but also integrate them to serve clients. We will transform from the mode of providing mechanical equipment to that of delivering a complete service system," says harmony.

The Belt and Road initiate put forward by China gives multinational firms great opportunities to give full play to their

advantages and realize sustainable development. "To positively response to the Belt and Road initiate, we are exploring an approach to apply our products and technologies to make contributions to the countries along the Belt and Road.
